

15. Provisional results will be published as soon as possible after the event at Rally Office in accordance with A61
16. Competitors will be identified by Competition Numbers displayed on left rear window of competing car. **These will be supplied by the organisers.** It is the responsibility of dual entrants to ensure that correct number is displayed
17. Marking and penalties will be printed in the appropriate section of the MSA Competitors yearbook 2011.
18. Competitors will be allowed to drive one car only during the event, but 2 competitors may enter and drive the same car.
Each driver will be given a maximum of **6 timed runs.** The fastest three to count for an award. To be classified as a finisher a competitor must have completed at least three timed runs of the stage.
19. Crash helmets and Overalls complying with current MSA regulations must be worn during all practice and official Runs.
20. A noise test will be carried out prior to mechanical scrutiny.
21. A Driver's briefing will be given in the paddock prior to the start of the event 10am sharp, and all drivers must attend. Cars must be ready to report to the start line on instruction of the Paddock Marshal. Re-Runs will be given at the discretion of the organisers.
22. Only one service vehicle per competing car will be allowed entry to the Service.
23. Once shown a red Flag you must STOP. Failure to stop is exclusion.

Only if a car is stopped by a red flag will they be allowed a re-run, all other situations, force major will apply

SUPPLEMENTARY REGULATIONS

1. Lough Neagh car & tarmac rally marshals club ltd will organise a Clubman Rally Time Trial on Saturday 17th September 2011 at Higgins estate, moneyglass demesne.
2. The meeting will be held under the General Regulations of the Motor Sports Association. (Incorporating the provision of the International Sporting Code of the FISA) and these Supplementary Regulations and any written instructions that the organising club may issue for the event.
3. MSA Permit number 66865
4. The event is open to all fully elected members of the club.
5. All drivers must produce a valid competition license (**Stage Rally National B or above**) and club membership.
6. The programme of the meeting will be as follows:
 - The event will be contained within Higgins estate moneyglass demesne.
 - Scrutineering and Signing On will start at 08.00 until 10am in the service paddock. All competitors must be signed on by 10.15am.
 - Drivers briefing 10.15am. Controlled convoy run at 10.30am
 - **First Official Run at 11am.**
 - Start order will be determined by Numbers and Classes
 - Cars will start singly at regular intervals
 - The starting signal will be visual
 - The finish line will be indicated by Stage Rally Finish Boards
 - Method of timing will be by Electronically Activated Beam.
 - Results will be based on a cumulative time; best three out of six runs.
7. The length of the course is approximately 1.6 miles of 100% surfaced roads. Cars will start at 30 second intervals. Beam timing will be in operation.
8. The event will consist of 8 classes as follows
 - Class 1 -Group N cars up to and including 2000cc
 - Class 2 -Group N cars over 2000cc
 - Class 3 -Clubman (Group A and modified) cars up to and including 1400cc
 - Class 4 -Clubman (Group A and modified) cars from 1401cc up to and including 1650cc having not more than two valves per cylinder
 - Class 5 -Clubman (Group A and modified) cars from 1401cc up to and including 1650cc having more than two valves per cylinder
 - Class 6 - Clubman (Group A and modified) cars from 1651cc up to and including 2100cc having not more than two valves per cylinder
 - Class 7 -Clubman (Group A and modified) cars from 1651cc up to and including 2100cc having more than two valves per cylinder.
 - Class 8 – All other eligible cars.

Turbo engined cars capacity will be determined by cc x 1.7
 Rotary engined cars capacity will be determined by cc x 2
 Protest regarding class eligibility must be made before the commencement of the first Official run

9. Awards will be presented as follows:

1st overall 4wd Trophy

1st overall 2wd Trophy

1st in each class Trophy

Overall winners will forfeit class awards

Additional awards may be presented at the discretion of the organisers

10. The entry list opens on publication of these regulations and will close at the standard fee on Monday 12th September 2011. Cheques/postal orders should be made payable to LNC&TRMC Ltd and crossed a/c payee. **All entries must be made on the official entry form**, please ensure all sections are completed including an email address and returned with entry fee. Entries will be accepted by post only. Entries by telephone will not be accepted. Selection of entries will be in order of receipt. The organisers reserve the right to refuse an entry. **Competitors who submit entries must not to cancel cheques if withdrawing their entry. Refunds will be issued minus an administration fee.**
